[42 u.s.c. 3201 note] notfor-profit corporations subject to the standards and criteria adopted by the secretary of labor under section 14(2),(3), and (4), nothing in subsection (a) shall be construed to require the compliance of any not-for-profit organization or educational institution of the state or any political subdivision thereof with those standards and criteria on account of its status as a not-for-profit corporation. the school gymnasium at the school attended by the victim shall not be considered a public recreation area. a family that provides paid recreation for members of the family shall not be considered a public recreation area.
